LiFeKinnex[™] Firmware Over-the-Air Update for 4-Bay Charger Connected to the Cloud

NOTE: These instructions are only valid for 4-Bay Chargers that have Inventek Wifi modules.

4-Bay Charger checks for firmware updates during power up or every 24 hours if plugged in. Firmware will update automatically when the following conditions are met:

- 1. All batteries need to be removed or fully charged when firmware update is available.
- 2. Charger needs to be plugged in and connected to WiFi.

Follow these instructions to manually run firmware update:

Remove all batteries from charger and unplug power cord before starting.

- **2** Plug in the power cord to turn ON charger.
- 3 Wait for device to connect to the WiFi. Go to eKinnex web portal to verify the charger is connected to the WiFi. eKinnex web portal: <u>https://lifekinnex.ekinnex.com/login</u> If it doesn't connect to the WiFi, use the LifeKinnex setup tool to program network credentials on the device. Set up tool: <u>https://www.ergotron.com/en-us/support/ekinnex/ekinnex-for-lifekinnex</u>
- Firmware download will start automatically. Wait for download to complete (takes about 30 min). The system will turn OFF, then back ON after the firmware update is complete.
